The Project

Citizens for Climate promotes the active participation of youngsters to the policy making process and to the civic life of their local community on climate emergency and sustainability issues through a wide range of activities which stimulates debates, reflection, and discussions. PUBLIC ASSEMBLIES

A series of public assemblies at the local level where students will present the results of the RANAS research to their community, gathering new input from local residents to complement their policy recommendations. This action is particularly aimed at citizens, with the goal of raising awareness, sharing information and including everyone in a bottom-up policy-making process.
